Duration of the Agreement: Subject to the terms herein and advertiser's signature on this agreement, advertisement will commence on the start date indicated herein, or such other date as may be agreed upon, in writing, by JCCC and advertiser. Advertising contract periods shall be only in the designated increments from the date of the initial posting.

Payment Terms: The advertiser agrees to pay the contract amount in full prior to the start date and advertisement shall not be posted until such payment is received. This contract amount is non-refundable and will not be pro-rated should the display of the advertisement be discontinued prior to the end of the contract period at either advertiser's request or as a result of advertiser's breach of this agreement.

Service Interruption/Limits of Liability: Advertiser agrees that JCCC shall not be responsible for any loss, damage or claims of any kind resulting from service delays and incomplete or interrupted service, regardless of cause or fault. JCCC's liability in such event will be limited to extension of contract period by the period of time advertisement failed to appear.

Rates: Member rates apply only if membership is maintained for entire duration of the contract period.

Representations, Indemnification: The advertiser represents that: (i) statements made in its advertisement shall not be false or misleading; (ii) all information and digital artwork provided shall meet JCCC specifications; and (iii) all content included in the advertisement shall not violate any criminal law or infringe or violate the rights of any third party, including the intellectual property rights of such third party. JCCC reserves the right to determine the suitability of all advertisements and to reject advertisements that do not meet its editorial criteria or the specifications. Advertiser agrees to indemnify and hold the JCCC, its officers, directors, employees, and agents ("Indemnified Parties") forever harmless from any and all liability, damage, loss, cost, claims and causes of action, of any kind, including reasonable attorneys fees, that may be incurred by any Indemnified Party, arising out of or related to advertiser's breach of the foregoing representations.
